

LIMITED WARRANTY Climate Control

Bendix Commercial Vehicle Systems LLC ("Bendix"), warrants to the original retail purchaser of the Climate Control Systems that all Climate Control products listed below sold by Bendix will be free from defective materials and workmanship for twelve (12) months or 100,000 miles (160,000 kilometers), whichever comes first.

The limited warranty does not cover defects caused by abuse, misuse or by improper installation, maintenance or service. The limited warranty applies to the following Climate Control Products: Compressor, Clutch Assembly, Filter Dryer (Accumulator), Blower Motor, Clutch Assembly, Expansion Valve and Switches. Coverage excludes the following: miscellaneous repair items and parts, tools, flushing, refrigerant, and any labor charges for removal or installation of a nonconforming or defective product or part thereof. **Unauthorized repairs will void this limited warranty.**

Product:

Product claimed to be defective must be returned freight prepaid via the OE dealership or authorized Bendix distributor within thirty (30) days after the date any defect is first discovered. Returns must be sent in the numbered box of the replacement unit. Climate Control compressors require replacement of receiver/dryer/accumulator, expansion valve/orifice tube, refrigerant, and proof of system approved flush (R141b and Dura Flush). In addition, the following system checks must be performed and documented:

- Inspect & clean inlet screen
- · Check for proper airflow through cooling fins of condenser and radiator
- Check for proper fan clutch or electric fan operation
- Check compressor clutch air gap
- · Verify proper type and amount of refrigerant oil
- · Hand turn compressor shaft (not just the clutch pulley) 10 times or more to clear oil from compressor
- Check compressor clutch electrical circuit for proper voltage
- After completing system evacuation, isolate AC system by shutting off high and low needle valves on gauge set and validate system maintains 29 in Hg for a minimum of 10 minutes.
- Use only R12 or R134a refrigerant. Recovered refrigerant must be checked for purity, moisture, and non-condensable gases.

System checks documentation and applicable products must be returned with compressor warranty claim. The entire warranty will not be honored if documentation and all stated materials are not returned.

Bendix will inspect the product and make the final determination as to whether the product is covered under this warranty. When a warranty claim is allowed, Bendix' responsibility is limited, at Bendix' sole option, to repair or replace the defective product. The replacement unit will be warranted for the remaining time period or mileage of the original warranty.

THIS LIMITED WARRANTY IS IN LIEU OF AND EXCLUDES ALL OTHER WARRANTIES, EXPRESSED OR IMPLIED, ARISING BY OPERATION OF LAW OR OTHERWISE, INCLUDING ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, AND IN NO EVENT WILL BENDIX COMMERCIAL VEHICLE SYSTEMS LLC BE LIABLE FOR INDIRECT, SPECIAL, PROGRESSIVE, INCIDENTAL OR CONSEQUENTIAL DAMAGES INCLUDING, BUT NOT LIMITED TO, COSTS INCURRED FOR SERVICE CALLS, TOWING, OR DOWNTIME.
