## NEW HAND BRAKE VALVES FOR DAIMLER APPLICATION

**The Hand Brake Valve (HBV) is used to control the vehicle's parking/ secondary brake system by gradual reduction of the pressure in the spring portions of the spring brake actuators.**

Daimler's success story of the Actros started in the middle of the Nineties. Meanwhile the model has been facelifted a few times. The first facelift was launched in 2003, the second one in 2008. Since then insiders call those facelifted model ranges it MP2 and MP3.

For both, MP2 and MP3, as well as the Atego model Knorr-Bremse offers hand brake valves in the independent after-market. The valves are available in different layouts, equipped with different features according to their OE specification.
